

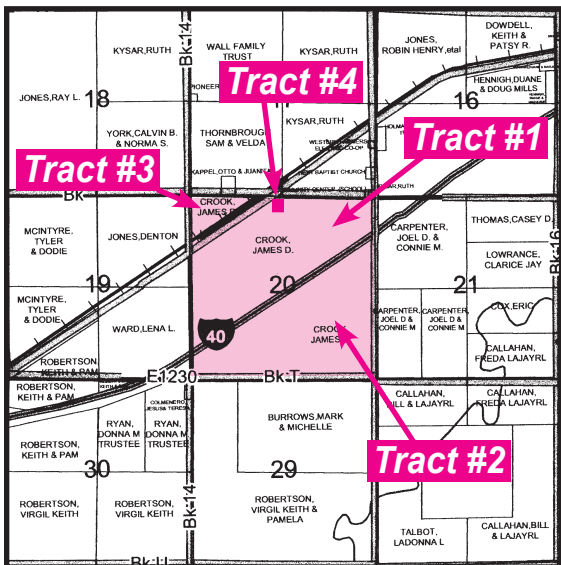

635 Acres of Beckham County Land Sold in Six Tracts

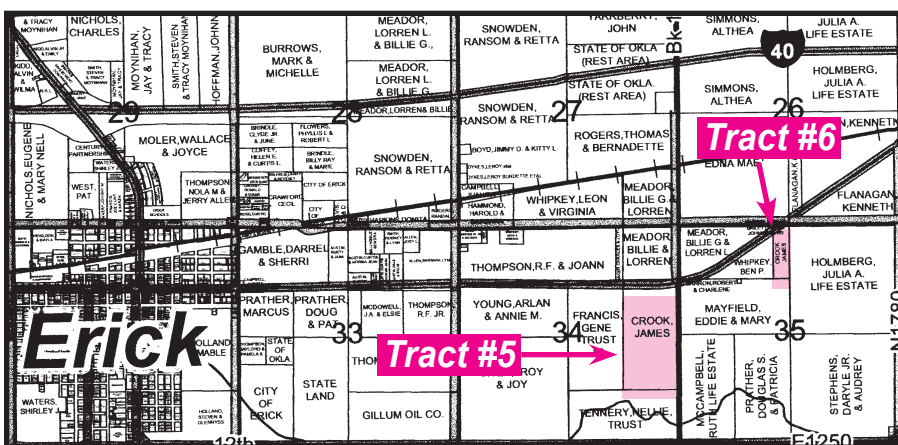
Sale Location: Exit 14 Hext Road on I-40 West of Sayre, OK, go North 1/10 mile to sale site. Watch for Signs!



TRACT #1 - LOCATION & DESCRIPTION: Exit 14 Hext Road on I-40 West of Sayre, OK, go North to Southeast Corner of tract (Section 20, Township 9 North, Range 24 West, I.M., Beckham County, OK) - Tract #1 - This good tract contains 259.21 acres (mol) of good native, improved grasses and cropland with a 198.1 acre wheat base. There is a good irrigation well that is approximately 194 feet deep and will pump 1,370+ gallons per minute. The 6 Tower Pivot and irrigation motor do not sell with this property and will be moved before closing. This tract has a good set of pipe lots, a 14' x 26' barn and a 14' x 80' 1982 Holiday mobile home with 3 bedrooms, 2 bathrooms, living room w/built-in entertainment center, kitchen w/dishwasher and pantry, garden tub in master bathroom, washer/dryer hook-up and has central heat & air.

TRACT #2 - LOCATION & DESCRIPTION: Exit 14 Hext Road on I-40 West of Sayre, OK, go South to Northeast Corner of tract (Section 20, Township 9 North, Range 24 West, I.M., Beckham County, OK) - This tract has 256.85 acres (mol) which is native pasture and cropland with a wheat base of 173.2 acres. There are pipe corrals that are 110' x 120', water well with submersible pump and electricity.

TRACT #3 - LOCATION & DESCRIPTION: Exit 14 Hext Road on I-40 West of Sayre, OK, go North to Tract #1, this tract is triangular shape just north of Tract #1 on the North side of Hwy 66 and Railroad Tracks (Section 20, Township 9 North, Range 24 West, I.M., Beckham County, OK) - This tract has 35.65 acres (mol) which is cropland and has a wheat base of 27.6 acres. There is also a water well.



TRACT #4 - LOCATION & DESCRIPTION: Exit 14 Hext Road on I-40 West of Sayre, OK, go North to Tract #1, this tract is in the Northwest Corner of Tract #1 (Section 20, Township 9 North, Range 24 West, I.M., Beckham County, OK). This tract has 5 acres (mol) and has a rock home with approximately 1,087 sq. ft. living area, 3 bedrooms, 1 bathroom, kitchen and living room. This tract also has a 36' x 60' Hay Shed.

TRACT #5 - LOCATION & DESCRIPTION: Exit 11 on I-40 West of Sayre, OK go 2 miles West on Hwy. 66 to Northeast Corner of property. (The NE/4 of the SE/4 and the SE/4 of the NE/4 South of Hwy. 66 in Section 34, Township 9 North, Range 25 West, I.M., Beckham County, OK). This tract has 71.5 acres (mol) which has bermuda grass and cropland with a wheat base of 56.9 acres.

TRACT #6 - LOCATION & DESCRIPTION: Exit 11 on I-40 West of Sayre, OK go 1 1/2 miles West on Hwy. 66 to Northeast Corner of property. (Beginning in the Northeast Corner of the NW/4 South 440 yards, West 127 yards, North 440 yards, East 127 yards to point of beginning less tract in Northwest Corner in Section 35, Township 9 North, Range 25 West, I.M., Beckham County, OK). This tract has 8 acres (mol) and is cropland.
