SALE LOCATION: Carter Public School Grounds - From the Intersection of Hwy. 34 & Hwy. 55 in Carter, OK, go South one-half mile on West side of road.

LEGAL DESCRIPTION: A 10 acre tract in the Southeast Corner of the Northeast Quarter and the Northeast Corner of the Southeast Quarter of Section 34, Township 9 North, Range 22 W., I.M., Beckham County, Oklahoma. Containing 10 acres (mol). Selling surface rights only.

AUCTIONEER'S STATEMENT: We will be selling the Carter Public School grounds in 3 separate tracts and will not be putting them back together. If property is sold to 2 or 3 buyers, buyers will pay for the cost of the survey.



TRACT #1 - From the South fence approximately 171 feet North; 653 feet West; 171 feet South; 653 feet East to point of beginning. Containing 2.55 acres (mol). This tract will have the concrete block gym which is approximately 90' x 180', the attached metal ag building which is approximately 30' x 100' and the apartments which are approximately 25' x 155'. The gym has all the seating, gym floor, basketball goals and locker rooms. The ag building has concrete floors, overhead door, walk-in door and is in good shape.



TRACT #2 - This will be from the point of 171 feet North on Tract #1, approximately 85 feet North; 653 feet West; 85 feet South; 653 feet East to point of beginning. Containing 1.25 acres (mol). This tract has the old house which is approximately 1,120 sq. ft. with a cellar, the lunchroom 30' x 96' which has the cookstoves, hood, dishwasher, counters and lots of cabinet space, this building would make a great restaurant location or community center. Also on this tract will be the 35' x 50' metal shed.



TRACT #3 - This will be from the North point of Tract #2 approximately 414 feet North; 653 feet West; 414 feet South; 653 feet East to point of beginning. Containing 6.20 acres (mol).
